¹ Under New York law, the University may expend so much of the Fund as the Board of Trustees deems prudent after considering the preservation and purpose of the Fund, economic factors including inflation, the expected total return from investment of Fund asset, the University's investment policy, and other resources and alternatives to expending the Fund, unless otherwise restricted by the donor in writing at the time of the gift.

² In the event gifts and commitments to the fund do not reach at least \$25,000 by June 30, 2023, they will instead be used to support a non-endowed fund to be known as the *Lata U. Sabnis, MD Residents Anesthesiology Education Fund* for the purpose outlined above.
