The 2024/25 per diem rates below have been approved by Finance. Projected, annual increases (4% if cost recovery, 6% if 85% cost recovery, 10% if less than 85% cost recovery).

For your budgeting purposes, all cost center per diems will increase as described below through June 2029 unless we reach cost recovery or realize cost savings to pass on to you. August 2024 Update: Due to the additional technical labor associated with ABSL2 biosecurity requirements, we must increase the per diem associated with ABSL2 cages to \$.826 (5.6%) effective September 1, 2024.
