### THE CAPITAL CAMPAIGN

During the last six months the Board of Trustees and staff have worked to infuse the capital campaign with renewed energy. I am pleased to be able to tell you that the campaign is again proceeding with spirit.


The campaign is now at 77% of goal. While we realize we must continue to work hard to realize our goal or, more happily, to surpass it, we are gratified by a number of things that have happened since I last reported to you.

•An anonymous benefactor donated an \$80,000 deferred annuity trust.

•In the late summer and early fall, chief executive officers of major local companies were invited to a series of lunches and tours of the new building. The companies these people represented had either not yet contributed to the campaign, or had not contributed at a level the Board thought appropriate. Before the visit, none of them fully realized the scope of the Center's programs and activities. They were uniformly impressed with the Center, its staff and students. Several former contributors have extended their pledges and some corporations are now supporters of EDC's fund drive. More lunchtime tours are planned.

•An alumnus of our perio program, Dr. Andrejs Baumhammers, M.S. '65, has asked dentists who enroll in his continuing education classes to contribute to the Center in lieu of paying tuition. The campaign has received a number of contributions in honor of Andy.

•J. Wallace Ely, a twenty-year trustee and former president of the Board, was the first chairman of EDC's

### STRONTIUM AND DENTAL CARIES IN THE ALBINO RAT

This study was undertaken to test the effects of strontium and fluoride on dental caries in Sprague-Dawley rats. Three experiments were performed designated as pre-eruptive, post-eruptive and pre- and post-eruptive with reference to the time of administration of strontium and fluoride. In the pre-eruptive and pre- and post-eruptive experiments rat pups were fed strontium, by esophageal intubation, in concentration of 0.0, 2.5, 5.0 and 10.0  $\mu\text{g}$  per 10 g body weight per day, with or without fluoride at 1.0  $\mu\text{g}$  per 10 g body weight per day, from age 3 to 17 days. The animals in the pre-eruptive experiment then received distilled deionized water. Those in the pre- and post-eruptive experiment were given supplement of 25, 50 and 100 mg Sr/1 with or without 10 mg F/1 in their drinking water. In the post-eruptive experiment strontium concentrations of 50, 100 and 150 mg/1 with and without fluoride at 10 mg/1, was given via the drinking water to rats from age 18 days to sacrifice. All animals were fed a cariogenic diet (MIT 200) *ad libitum* and sacrificed at age 56 days. Caries was evaluated in the rat molars and strontium concentrations in rat surface enamel were assayed for.

There was a linear relationship between the concentration of strontium in the drinking water and surface enamel when strontium was given pre-eruptively, post-eruptively, or pre- and post-eruptively. The highest mean enamel strontium concentrations were found in the pre- and post-eruptive experiment. These were significantly higher than those of the pre-eruptive experiment, implying a post-eruptive uptake of strontium. The groups receiving 100 mg Sr/1 and 10 mg F/1 pre-eruptively, or post-eruptively, had significantly greater uptakes of strontium than those receiving 100 mg Sr/1 alone. The implication was that fluoride increased the uptake of

strontium by enamel in these groups. The post-eruptive administration of strontium was associated with negative correlations between surface strontium concentrations in enamel and bucco-lingual caries, (L) and (E). These correlations were not statistically significant but the small numbers of animals in each group could account for this.

The pre-eruptive administration of 2.5  $\mu\text{g}$  Sr per 10 g body weight per day with or without 1.0  $\mu\text{g}$  per 10 g body weight per day was associated with statistically significant decreases in sulcal caries. When the supplements were continued through the post-eruptive period, the groups receiving 25 or 100 mg Sr/1 had significant reductions in caries which were enhanced by the addition of 10 mg F/1. Those receiving supplements of strontium and fluoride, only during the post-eruptive period, had significant reductions in bucco-lingual caries when given 50 mg Sr/1. The addition of 10 mg F/1 to this concentration produced the lowest caries scores in the post-eruptive experiment. These scores were significantly lower than those in the group receiving 10 mg F/1 alone, implying a synergistic interaction between strontium and fluoride on caries.

Gary Rogoff received his bachelor's from the University of Rochester, his D.D.S. from New York University College of Dentistry and his prosthodontic certificate from EDC in 1974. While working on his Master's, he had a combined appointment at the Center as clinical assistant in Gen-Den and clinical assistant and research fellow in Prosthodontics. He is now assistant professor of prosthodontics at Tufts University School of Dental Medicine. His father and brother are both dentists.

Gary's hobbies include skiing and photography. Since he and his wife, Sue Bricker, have moved to the Bay State, they are enjoying their Boston Ballet and Symphony subscriptions, trips to the Quincy Market and Museum of Fine Arts and rides down the Charles in swan boats. ### THE RELATIONSHIP OF ENDOGENOUS PLASMA ESTROGENS TO THE MATURATION OF HUMAN FEMALE BUCCAL EPITHELIUM

The epithelium lining the oral cavity displays great variability in its reaction to functional stress, and this can cause substantial clinical problems. Atrophic or immature epithelium is more easily traumatized than normal epithelium. Since estrogens have been shown to have a direct effect on the thickness and degree of maturity of vaginal epithelium, it has been suggested by clinicians that these steroid hormones have a similar effect on oral epithelium.

This investigation was designed to correlate the degree of maturity of buccal epithelium with levels of endogenous plasma estrogens. Smear preparations were collected three times per week from the mouths of 57 normal females for at least three menstrual cycles. The subjects included



those taking oral contraceptives as well as those not taking them. After fixation and staining, the smear preparations were examined microscopically and cell body and nucleus outlines traced with a camera lucida. A planimeter was then used to measure cell and nucleus surface areas as a sensitive indicator of epithelial maturity.

Blood was collected weekly from most of the subjects, and the plasma of the noncontraceptive group was analysed by radioimmunoassay for levels of estradiol/estron.

Planimetric measurements were made of a total sample of 86,250 buccal epithelial cells. The mean cellular area was 2192  $\mu^2$ . The mean nuclear area was 54  $\mu^2$ . The mean N/C area ratio was 0.027.

Results demonstrated no correlation between plasma estrogen levels and degree of maturity of the buccal epithelium. There was no evidence of periodic changes in buccal epithelial maturity corresponding with the menstrual cycle, and the use of oral contraceptives by one group of subjects did not significantly influence the data.

### Prosthodontics


