### Continuing Education

#### The Branemark Procedure

Gerald N. Graser, D.D.S., M.S., chairman of the Center's Department of Prosthodontics, and Bejan Iranpour, D.D.S., M.S., chief, Department of Dentistry, The Genesee Hospital, and senior clinical associate and consultant in oral surgery at the Center, had eschewed working in the field of implantology until they became aware of the biologic research and clinical trials of Per-Ingvar Branemark, M.D., Ph.D. Dr. Branemark, an orthopedic surgeon and director of the Institute for Applied Biotechnology in Gothenburg, Sweden, and his colleagues have published the results of their extensive scientific research and clinical experiments for over twenty years.

Dr. Graser says, "Having a dental implant available with the scientific and clinical background of Branemark's has a profound effect upon treatment planning the prosthodontic needs of the dental patient. No longer are conventional crown and bridge, or removable dentures, the only alternatives."

Dr. Iranpour says, "The Branemark dental implant system is supported by more research and clinical studies than any other oral implant system and withstands scientific scrutiny."

The Eastman Dental Center (EDC) and The Genesee Hospital (TGH) are together one of the five original Branemark tissue integrated prosthesis (TIP) training institutions in North America. The others are the University of Toronto, the Mayo Clinic, the University of Texas at San Antonio, and the University of Washington in Seattle. EDC and Genesee have sponsored TIP courses since 1984. Registration in such courses is limited to oral surgeons and periodontists for the surgical aspect of the training, and to prosthodontists and general dentists with extensive experience in prosthetics, for the prosthetic aspect.

To summarize the technique, the surgeon inserts small titanium implants (fixtures) into the mandible or maxilla while the patient is under local or general anesthesia. The number of fixtures implanted depends upon the number of teeth to be

replaced and on the condition of the bone. The implants are covered with the mucosa for up to six months to achieve bonding between bone and titanium (osseointegration). A second procedure will then be performed to attach titanium abutments to each fixture. The prosthodontist will then fabricate and attach a fixed prosthesis to the implant-supported abutments.

The November 6-8, 1986 course attracted nine EDC alumni. Taking the surgical aspect were Michael J. Deasy, Perio '71, Neil D. Hollyfield, GenDen '78, Michel Perrier, GenDen '78, Brian E. Reed, Perio '82, M.S. '83, and Constantine Stamatelakys, Perio '86. Enrolled in the prosthetic aspect were Peter Laliberte, GenDen '76, John Poirier II, GenDen '78, Mohssen Ghalichebaf, Prostho '79, and R. Jed Fox, GenDen '80.

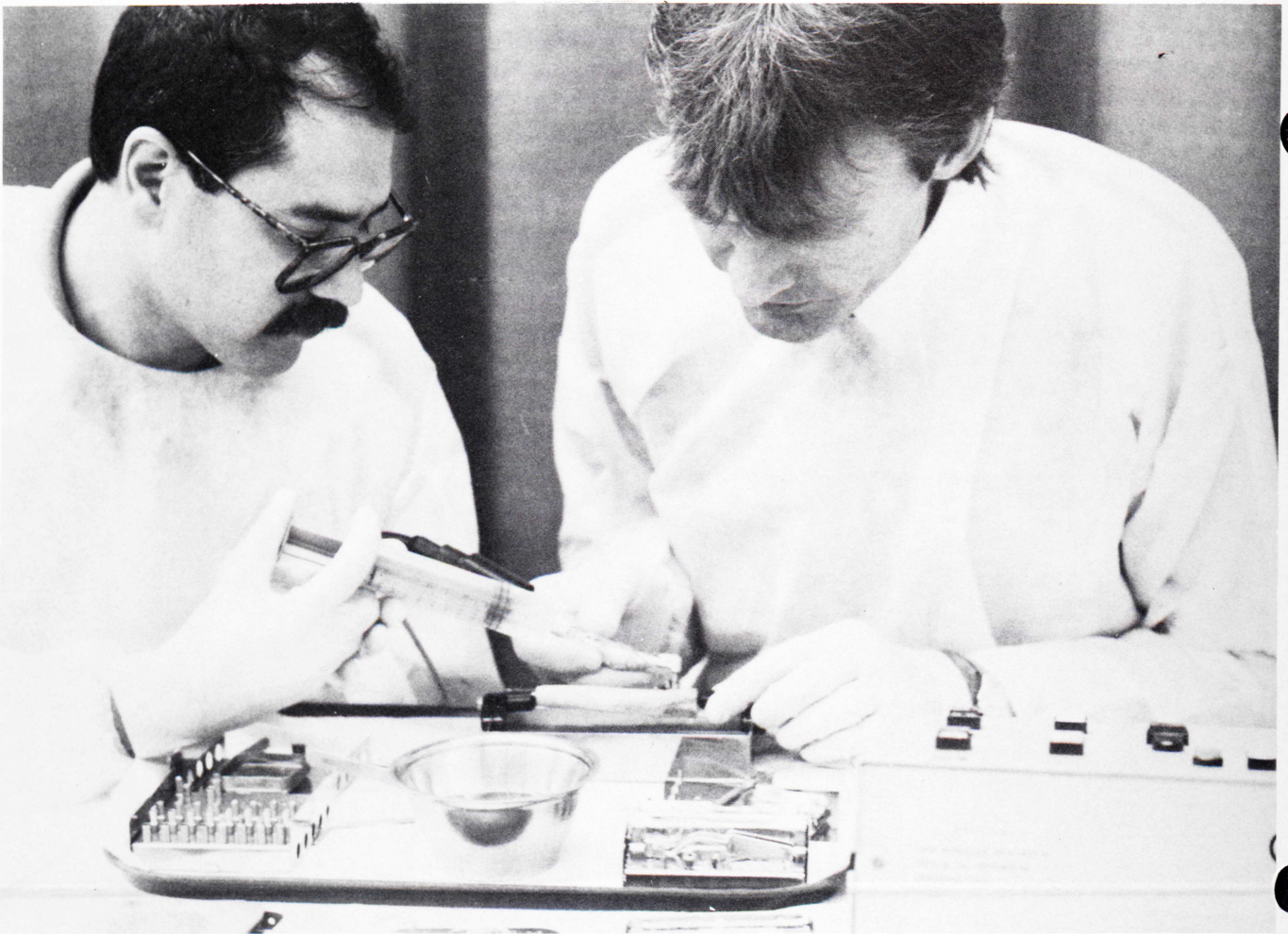

with the Branemark tissue integrated prosthesis at EDC/TGH. Her surgery was done at The Genesee Hospital by Dr. Bejan Iranpour; her prosthetic work at the Center by Dr. Gerald Graser. Judith was at the Center as one of the patients presented to TIP course participants. Judith and the EDC staffer arranged to talk about her TIP experience a few days later.

Judith lives in a cozy apartment near Rochester's Memorial Art Gallery. She is a creative, articulate woman with enormous intellectual and physical energy. Her paintings decorate the walls. Found objects grace the top of her bookcase. A score for a work she's rehearsing with Madragalia, a local performing group, lies open on the piano. She designs and sews costumes and clothing. Her workroom is full of sketches, swatches, and spools of colored thread that sit boxed on wooden wall shelves like flamboyant sculptures. Judith VanNess has, at various times, run a day care program and worked at the Memorial Art Gallery, the Margaret Woodbury Strong Museum, and the Rochester Museum and Science Center.

She says, "I have been buying my own teeth since I was 21 as a result of dental neglect as a child. About nine years ago, I went for a rebase on my denture and my dentist said, 'I don't like the way you appear. Because of bone loss, you have an 83 year-old mouth.'"

Judith shakes her head at the memory and comments, "I don't know. I have no ridge at all."

She then tried a subperiosteal implant that "never healed pro-

perly, and was inflamed and infected from the beginning."

She was on increasing doses of antibiotics for a number of years. On the recommendation of an orthopedist, she made an appointment to see Bejan Iranpour. Dr. Iranpour suggested that because of the infection, the implant would have to be removed.

Judith says, "I had so many questions and I was impressed that he would sometimes answer me by saying, 'We don't know.' He had enough assurance to say he didn't have answers to some questions but that, for instance, if *this* happens, we might be able to *that*, and that somewhere along the line I would be better off than I was then. Also, it was not just infection, it was inflammation. I'm arthritic and maybe have a tendency to inflame. I'm a singer and my whole face would ache after rehearsal."

She recalls her initial meeting with Dr. Graser. "I was not happy with my previous dentures. I had this pushed-in tight little mouth. I have a sharp-featured face and had to have a toothier look. I was pleased when Dr. Graser listened to me about what I had looked like before I lost my teeth."

Judith continues, "I've studied some anatomy. I've educated myself as much as I could about this. I have some sense of esthetics. And when I said I want to look like my own family, that makes good sense to me."

"I had no pictures of me. I was always the one who took the pictures. I stayed away from the camera. I had my teeth out when I was 21, and I avoided having my picture taken. I brought in some family photographs and Dr. Graser looked at them and

also went by what I said. He got it pretty much on the first try. He listened and when I looked at him and said, it's obvious that you're paying attention to what I'm saying, he said, 'Well, we try very, very hard to manage something which is in harmony with the bone structure of the face.'"

Judith is pleased with her appearance. She says, "My mouth is me again!"

She talks about eating with her prosthesis. "It was a re-learning process. I had to learn to bring food more forward in my mouth than I did before. The front part of my mouth is the strongest. Before this new prosthesis, it was the part in trouble. It all fell into place in about three weeks. I realized I wasn't paying attention any more to what I was eating. It's natural now, and I'm comfortable with it. Biting is better. I haven't tried biting into an apple that hasn't been cut. I haven't done that for 25 years, I just never thought about it. I automatically cut it up. But I eat bagels, and I've had steak."

Judith VanNess concludes, "For the first time in years, I don't have pain in my jaw. And I've been treated like a human being, an intelligent person, a rational person who not only has the privilege of asking questions, but the duty to become informed. And that's what I appreciate. Partly the procedure, but over and above that, knowing I would have to be continuously monitoring this apparatus, to be taking care of myself very, very careful-

ly, and have the support of the people who are really involved with me as a person as well as with my jaw, is really important to me. There's a lot of goodness in the people at Eastman and Genesee. They've never been rough in the handling of me in any of the procedures. Dr. Graser and Dr. Iranpour make a good team!"

## Board of Trustees

Max M. Farash, president of the Eastman Dental Center Board of Trustees since 1985 and board member since 1974, has received the prestigious Herbert W. VandenBrul Entrepreneurial Award for 1986.

The award was created at the Rochester Institute of Technology (RIT) in 1984 through an endowment fund established by Mr. VandenBrul in cooperation with RIT's College of Business. Mr. VandenBrul is a co-founder of R.F. Communications, Inc., now a division of Harris Corporation.

The award is presented to an individual who successfully develops a business that improves Rochester's economic life or whose innovative management skills change the course of an existing business. The award recipient is invited to RIT to lecture on entrepreneurship.

A committee of College of Business faculty, and civic and business leaders selects the recipient.

### Special Gift

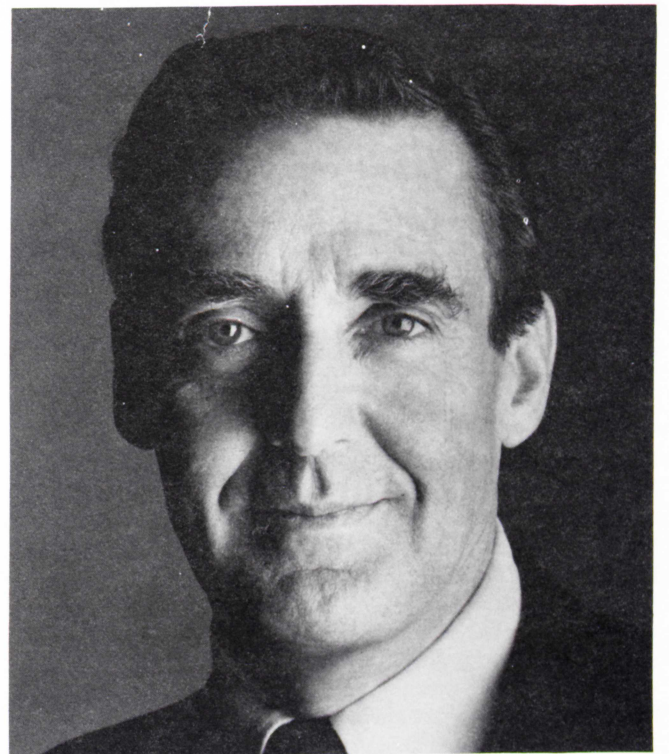

### In Memoriam

James C. Henderson, a trustee of the Eastman Dental Center since 1981, died November 5.

EDC's director, Dr. William D. McHugh, writes:

"Mr. Henderson died tragically after a long and courageous battle with cancer. A former president and CEO of Rochester Telephone Corporation, he foresaw deregulation of the telephone industry and that telephones would be sold in stores rather than exclusively by telephone companies. Under his leadership, Rochester Telephone moved vigorously into the modern era establishing a holding company and an unregulated subsidiary involved in equipment sales and long distance networks in such distant places as Hawaii. He was nationally recognized as a leader in the telecommunications industry and the person primarily responsible for transforming Rochester Telephone from a laggard to the forefront in product and profits.

"Jim Henderson brought the same vigor and vision to the Board of Eastman Dental Center. He was an active Board member, treasurer, and chairman of the important Long-Range Planning Committee. He will certainly be missed and our sincere sympathy is extended to his wife, Lisa, and to his children."

The Harold A. Eskew Memorial Fund has been established in the Eastman Dental Center's Department of Orthodontics in

memory of the eminent orthodontist. Dr. Eskew died suddenly in December 1985.

Dr. Robert W. Baker, senior clinician in the Department of Orthodontics, and Dr. Richard Radke, a prominent orthodontist in Overland Park, KS, lifelong friends and associates of Dr. Eskew, initiated the fund as a living memorial to their colleague.

"Harold Eskew was not only our friend, but also our companion in orthodontics. He was one of our mentors—an educator, innovator, teacher, scholar, leader in the field, and one who shared ideas. He taught more people how to deliver orthodontic care to patients in the proper manner than anyone else we knew," said Drs. Baker and Radke.

Interest from the Harold Eskew Memorial Fund will be used to provide fellowships for EDC postdoctoral orthodontic students who have the potential to be leaders in the field.
