Highland Family Medicine Redesigns Practice to Address COVID-19 Pandemic

Highland Family Medicine is a medical practice where walk-ins are welcome. So when the area saw its first signs of COVID-19 they knew they had to take action to ensure patient and staff safety.

At 777 South Clinton they quickly closed off the front entrance and set up nurses and medical assistants as screeners at the back door. If a patient had COVID symptoms they were escorted to what they called the Respiratory Care Clinic in the closest suite to the entrance. Suite 200.

Initial screening questions were about travel, respiratory symptoms, cough, and fever. That progressed to adding other symptoms as they were determined to be signs of COVID, temperature taking, and mask and hand sanitizer distribution, according to **Mathew Devine**, **DO**, Medical Director, Highland Family Medicine.

Staff had to redesign their practice model while triaging and treating COVID patients. The question "how can we still meet and/or see patients who had acute and chronic needs while keeping everyone safe?" was at the heart of their planning according to **Heidi Tompkins**, Nurse Manager, Highland Family Medicine.

HFM Supports Black Lives Matter

Since our last newsletter, the novel coronavirus hit our Finger Lakes region. In March 2020, Medical Director **Mathew Devine**, **DO**, together with **Brenda Houtenbrink**, our new Senior Program Administrator, and



our outstanding management team, developed a respiratory suite designed to provide patients with acute respiratory symptoms rapid access to care with a clinical team well versed in the use of PPE. Our positivity rate for COVID testing for the month of March was 13% of tests obtained. Our positivity rate steadily declined to a nadir of zero in June and September. Monroe County, under the able leadership of County Health Commissioner **Michael Mendoza, MD, MPH**, "crushed the curve." October's data for Highland Family Medicine shows a positivity rate of 2.6%, which is mirroring our local trends for overall positivity.

I am beyond proud of the way our teams handled the initial phases of the pandemic—Family Physicians and Family Medicine Residents were prepared to reassign to inpatient settings, and Family Nurse Practitioners were prepared to pick up more of the outpatient practice as well as managed many walk-in patients. All clinicians and staff made a rapid switch to telephone and video visits to enable our patients ongoing access to care. While our behavioral health team tended to the mental health of our patients, they also provided "Zoom check-ins" groups for faculty and staff, and increased the number of Balint groups for the residents to provide support during such an unprecedented time of stress and uncertainty. Drs. Sachiko Kaizuka, Susan McDaniel, and **Tziporah Rosenberg** developed the "Breath of Fresh Air," a thrice weekly e-mailed missive containing inspiring photography, poetry, music, and other media to help us all find moments of beauty.

By early summer, our clinical volume had returned to over 100% our pre-COVID volume, with under 10% virtual visits. In the midst of the pandemic, I am pleased that we were able to welcome aboard our new Family Medicine Interns, who hail from across the nation, 2 new FNP residents, and several new faculty—1 Family Nurse Practitioner and 6 Family Physicians, who replaced vacancies from the last several years. Our Nurse Practitioner Residency, under the leadership of **Kristin Smith, DNP**, and **Aaron William**, **FNP**, is expanding to the Tri-County Family Medicine practice in Dansville and Canaseraga, New York. We are all looking for a "new normal" as we anticipate another COVID surge with the onset of cooler weather. As ever, I remain honored to work with such an incredible team of colleagues.

Colleen T. Fogarty, MD, MSc, FAAFP, William Rocktaschel Professor and Chair of the University of Rochester Medical Center's Department of Family Medicine, has been accepted as a Fellow in the 2020-2021 Hedwig van Ameringen Executive Leadership in Academic Medicine® (ELAM) Program for Women. Established in 1995, the ELAM program, which is hosted by Drexel University College of Medicine, offers an intensive one-year fellowship of leadership training with extensive coaching, networking and mentoring opportunities aimed at expanding the national pool of qualified women candidates for leadership in academic medicine, dentistry, public health, and pharmacy.

Acceptance into ELAM is determined through an annual competitive selection process, in which approximately 60 candidates are chosen each year. "I am truly honored to be part of this distinguished program," said Dr. Fogarty.

Each Fellow works on an Institutional Action Project addressing a need or priority of their institution. This project will be developed jointly with a senior staff person to ensure that it will be meaningful and productive for the institution and fellow.

Dr. Fogarty's Institutional Action Plan is to develop training and on-boarding curricula regarding equity and race for new University of Rochester School of Medicine and Dentistry faculty. She will work in collaboration with Dr. Adrienne Morgan, associate vice president for the URSMD Office of Equity and Inclusion, and

Department of Family Medicine Physician Serves as Monroe County Commissioner of Public Health

When **Michael Mendoza MD, MPH**, former medical director of Highland Family Medicine, took the post as Commissioner of Public Health for Monroe County in 2016 no one dreamed of a pandemic in the future. But when COVID-19 presented in the Rochester, New York area he was ready to lead the county with information, education, and compassionate leadership. Under his watch cases and death rates in the area were kept low and he helped guide hospitals and physicians on best practices for patient care during the pandemic and ways to gradually re-open facilities with precautions this summer.

Dr. Mendoza, who honed his passion for public health in graduate school, still practices medicine at Highland. He feels that the skill set of a family medicine doctor helped him with his approach to the pandemic. "Being a family medicine doctor means approaching care for the patient from a broad perspective and dealing with a lot of uncertainty," he said. "And uncertainty is the hallmark of this pandemic."

He continued to wear two hats as commissioner and physician with only a short break from practicing medicine during the pandemic. "Being a doctor is important to me," he said. "Seeing patients has put everything in perspective for me."

Along with the pandemic his work as commissioner is focusing

on issues of systemic racism, mental health, the opioid crisis and access to health care. He is cautiously optimistic that Monroe County is prepared for a possible rise in COVID-19 in the fall but stresses that incidents can be kept low with the use of masks and social distancing. Flu shot compliance is important.

HRSA Awards \$1.2 Million to Train Nurse Practitioners

A \$1.2 million grant from the Health Resources and Services Administration (HRSA), an agency of the U.S. Department of Health and Human Services, will help expand the Nurse Practitioner (NP) Residency program that is integrated into the University of Rochester/Highland Hospital Family Medicine Residency Program. Funding of \$400,000 each year for three years will be used to expand the NP residency program from two residents per year to four residents per year, with a rural medicine component.

The Highland Family Medicine (HFM) Nurse Practitioner Residency program was developed in collaboration with the University of Rochester School of Nursing. It is the first program of its kind in New York state. "We are very excited about this opportunity to expand our program and help provide more health care in rural communities," said **Kristin E. Smith, DNP, FNP-C, AAHIVS**, who serves as director.

Created in 2016, the program is accredited by the National Nurse Practitioner Residency and Fellowship Consortium (NNPRFTC). The HFM clinic has the third oldest physician residency program in the country, internationally recognized for leadership and innovation in the integration of behavioral health into primary care practice. These qualities were brought into the NP residency program at its inception in 2016, where residents from all disciplines train together to create an inter-professional collaborative learning environment.

She is active in her community serving on the Board of Directors on the American Heart Association, New York City. As a board member, Dr. Harris served as the campaign leader for Children's Heart Health Campaign. She is committed to improving the lives of communities and is an advocate and activist to increase awareness for improving healthy food access in NYC.

Dr. Harris stresses that family medicine physicians are vital to health care in our country. "Training in biopsychosocial medicine and health disparities enable family medicine physicians to be at the forefront in policy, advocacy, translation, and integration for our communities," said Dr. Harris. "How we continue to position ourselves within health and health systems will help family medicine become the best primary care voice for the driving outcomes."

Telemedicine by video or phone was quickly implemented to help give patients access to clinicians. Well child and prenatal clinics were located in a separate part of the building at 757 South Clinton. "All of the processes that we put in place didn't happen overnight, but we did everything as fast as

we could and in step with how information was changing daily," said Tompkins.

Dr. Devine and **Dr. Rachel Bian** put together a tutorial to educate staff on new procedures and work flow. Staff input was involved and was critical to getting these sessions to run smoothly. "This was truly a team effort," said Dr. Devine. "The entire practice helped create our plans in comprehensive, efficient ways. Camaraderie and dedication were our secrets to successful implementation."

As more awareness of COVID-19 increased, patient walk-ins dropped. After redesigning the facility, in-person visits started to increase week

after week, "At this point we are over 90% back to in-person vs telemedicine visits," said Dr. Devine.

Highland Family Medicine has created day long walk-in/acute care sessions that allows them to continue to screen, diagnose, and treat COVID. These sessions also see other acute needs and have helped to decrease unnecessary visits of patients in the Emergency Department or Urgent Care.

"We continue to be vigilant and prepared with plans that would allow us to transition if there is another surge in our community," said Tompkins. "We are currently in a better place with supplies and knowledge if we were to have a Continued next page

Class Prepares Providers and Staff for Obstetric Emergencies

Advanced Life Support for Obstetrics (ALSO) is a day long course involving simulations of obstetric emergencies to prepare providers and staff to manage them efficiently within a standard framework. The course has been taught for nearly 30 years by Highland Family Medicine (HFM) faculty, first in conjunction with the other NYS Family Medicine residencies, now as a full day course at HFM. This year, **Sarah Hudson, MD**, Assistant Program Director, URMC Family Medicine Residency, Brown Square Site Maternity Care Faculty is course coordinator.

"ALSO is an intensive course meant to standardize approaches in common obstetrical emergencies," said Dr. Hudson. "The hands-on skills demonstrated and taught during

resurgence. Our team will be ready to care for our patients and meet the challenges."

"I will always prefer to see patients in person," said Dr. Devine. "The ability to be in a room with a person, getting to know them and see them is a special part of being a family medicine physician. I am grateful that we could accommodate and

accomplish visits with phone and video when we had to and I do foresee these types of visits could be continued in the future."

"This is a long, long marathon," said Dr. Devine. "But we continue to get more information and learn about the virus, testing, antibody testing, vaccine development, and more. Because the population is taking precautions we are seeing drops across the country in diagnoses like strep throat and RSV and the flu season ended early in the spring. This shows that people are doing the right things and need to continue to keep doing them. Social distancing, mask wearing, hand washing and getting a flu shot continue to be best practices."

these courses require in-person participation, although we will be slightly modifying our course to meet the social distancing requirements of our current pandemic."

The course infrastructure has changed and evolved over time, though the core emphasis has always been around improving safety in maternity care. The shift has been from a primarily content-focused course to one that now really emphasizes team-work, collaboration, and communication.

"The Department of Family Medicine has long recognized the importance of interprofessional work across the spectrum of our work, and for many years has been honored to include our labor & delivery nursing colleagues as both learners and teachers in these courses," said Dr. Hudson. "I have taught these courses for 10 years now, and truly enjoy the opportunity to help learners develop competence and confidence in the care they provide for women and families."


