This type of event would change the way everyone accesses our services, drops off patients, and communicates.

Important points to remember:

- Personal safety is of utmost concern.
 Always follow the direction of security personnel and law enforcement. Obey traffic barriers and signage.
- The reunion of patients with their families is very important. Alway have a patient's identification available.
- Pets will not be allowed in the facilities. Contact the local humane society (Ontario County 585.396.4590, Monroe County 585.223.1330).

Accessing The Building During Lockdown

Thompson Health maintains the right and the ability to lock all entrance and exit points of the main campus. Do not accommodate an unauthorized person's request to enter building.

All exterior doors at Thompson Health's main campus are numbered and clearly marked with brown and white signs at each door.

The primary helipad location is on the west side of the campus, clearly designated by landing lights. Alternative locations are available per Incident Command's designation.

Patient Drop Off/Pick Up During Activation

Depending on the incident and its potential effect on our building, decisions for dropoff and pick-up locations will be made by Incident Command. EMS will be informed and given directions by the security personnel upon arrival.

As is standard, the ambulance bay door will-remain locked. Use the intercom system located to the left of the door to alert the charge nurse of your arrival. Please note this location is under camera surveillance.

Contaminated Patients

Contaminated patients cannot be taken to the ambulance bay.

Although the patient may have been grossly decontaminated at the scene, we will require the patient to go through our DECON process.

No patients will be allowed into Thompson Health's Emergency Department until they have been approved by the DECON Team leader or DECON medical director.

Ambulance companies are responsible for decontaminating their own vehicles.
