
- Local- Office of Emergency Management (OEM), mutual aid, regional mutual aid, private agreements, associations, healthcare systems

Where Assistance May Come From

- A request starts at a local jurisdiction, through the County Emergency Management Office to the State Office of Emergency Management. The State will fill the request or seek assistance from the federal government;
- NYSDOH : Medical Emergency Response Cache (MERC)
- Assistant Secretary for Preparedness and Response (ASPR): Strategic National Stockpile (SNS)
- Health and Human Services (HHS): Authority to release SNS
- Division of Homeland Security (DHS)/Federal Emergency Management Agency FEMA: Assigns HHS missions under Emergency Support Function – 8 (ESF-8) – Public Health and Medical Services Annex

What is the Medical Emergency Response Cache (MERC)?

- State stockpile program containing pharmaceuticals, durable medical equipment and supplies
- MERC assets are intended to supplement local level response
- MERC assets can sustain a large event response prior to SNS arrivalarrival within 4 hours of approval
- MERC assets will likely be the first outside supplies available to an affected area during an emergency

- Ciprofloxacin/Doxycycline (Cipro/Doxy)
- · Durable medical goods
- Ventilators (LTV 1200)
- · Other supportive items
